#### US/ICOMOS and Partners Advocate for Continued US Engagement in the World Heritage Program



On May 14, US/ICOMOS Advocacy Chair T. Destry Jarvis enlisted partners in <u>a joint letter addressed to Chairman Lisa Murkowski and</u> <u>Ranking Member Tom Udall of the Subcommittee on Interior,</u> <u>Environment and Related Agencies of the Senate Committee on</u> <u>Appropriations</u>.

The letter begins:

As organizations dedicated to the protection and preservation of the historic and cultural resources of our nation including but not limited to World Heritage Sites, we write in support of the United States' engagement in the World Heritage Program. We urge you to appropriate \$1.926 million for the National Park Service's International Park Affairs including at least \$1.25 million for the Office of International Affairs (OIA) to ensure our robust involvement with the program and to support many United States communities and sites seeking nomination to the World Heritage List. We also urge Congress to reject the Administration's proposal to drastically reduce overall program funding for International Park Affairs while also shifting the Southwest Border Resource Protection Program into OIA. For the past three fiscal years, Congress has consistently appropriated \$1.648 million for International Park Affairs, including \$942,000 for the OIA. We believe that a modest increase to \$1.926 million for International Affairs is appropriate and merited.

In honor of National Historic Preservation Month, this month we feature the National Trust for Historic Preservation (NTHP), an organization that our members and friends will be very familiar with and a longtime IEP host. in fact, the Historic Sites Department of the NTHP has hosted an IEP intern every summer since 2013, putting a string of talented historic architects to work on NTHP projects. Ashley R. Wilson, AIA, ASID and <u>Graham Gund</u> Architect for the Historic Sites at the NTHP, oversees the work of IEP interns at the Trust among her many other responsibilities. She writes of the interns, "Our list of amazing architects includes Maria Martinez (Spain), Florence Declaveilleve (France), Renee Muratore (Australia), Desiree Valadares (Canada), Vilte Janusauskaite (Lithuania), Kyra Lomas (Western Australia) and we are looking forward to Raffaella Corrieri's (Malta) arrival in June. We enjoy learning from their global experiences of heritage conservation and we always are impressed with the talent, personalities and promise of these young professionals." The NTHP is a wonderful place for interns to gain an understanding of US preservation policies, attitudes and places. They also gain a deeper picture of preservation in the US today, since, as Ashley writes, "At the National Trust we explore creative ways and alternative uses for endangered places and historic site sustainability. Besides stewarding our landmark buildings, we showcase hidden heritages, devalued places, highlight racial justice, smart growth, equitable redevelopment and strive to connect the past with current events."

This summer's NTHP intern Raffaella Corrieri will visit many NTHP properties for her work. Raffaela will be working on the final stages of construction drawings for the Brick House at Philip Johnson's Glass House in New Canaan, CT, and the replacement copper roof at Oatlands, in Leesburg, VA. She

will also work at Chesterwood, Daniel Chester French's summer home and studio in the Berskshires, which will be undergoing a generational rehabilitation: the Trust will be adding accessibility and all new mechanical systems. Rafaella will also participate in the National Trust's robust intern education program, learning about preservation initiatives, communities and entities in Washington, DC.

US/ICOMOS truly appreciates the opportunities that the National Trust for Historic Preservation offers to our IEP participants. Thank you, NTHP, for being such a wonderful host year after year!
